### THE CONTRACTURAL OBLIGATIONS AND COMMITMENTS AS DEFINED BELOW ARE THE SOLE RESPONSIBILITY OF THE ADOPTER(S):

- \* To adopt this animal as a companion pet, and never for it to be used for research or given as a gift.
- \* To provide the animal with an indoor living environment; appropriate exercise; adequate fresh food and water; love, affection and attention.
- \* To provide animal with all attention, care and treatment as recommended by a veterinary professional including but not limited to: checkups; vaccinations; flea, tick and heartworm preventatives; accident, sickness and emergency.
- \* To provide a secure collar (dog) displaying and ID tag and rabies tag
- \* To obey all state and municipal regulations governing licensing, ownership, custody, control and care of the animal
- \* Not to tether animal or closely confine animal in conditions or manners that would be considered to cause immobilization, pain or suffering
- \* To take actions preventing, and accept liability for any behavioral or physical damage to the animal
- \* To hold Time To Live blameless for injury or death that other animals or people may incur
- \* To allow Time To Live representative permission to enter Adopter's premises to ensure that the conditions of this contract are being upheld and to remove animal from Adopter if necessary without constituting a trespass event
- \* To surrender, on demand, ownership of animal to Time To Live if Adopter fails to uphold the conditions of this contract
- \* To pay all costs, including professional legal fees, if Time To Live must take action against Adopter or associated persons to execute any conditions of this contract
- \* To allow writing and photos of animal, Adopter and related parties to be published (website, newsletter, etc.) by Time To Live without notification or compensation
